3 AAMA 2025 - 2026 National Delegate  
4 Period Ending April 2026

6 This delegate was elected by the 2025 OSMA General Assembly to represent the Oregon  
7 Society of Medical Assistants (OSMA) at the 2025 AAMA Annual Conference in Arlington, VA,  
8 during the dates of September 19 to September 22, 2025. Prior to the AAMA Conference, this  
9 delegate attended the virtual AAMA Bylaws Review on August 25, 2025, virtual House of  
10 Delegates (HOD) Orientation session on September 6, 2025, and Meet the Candidates on  
11 September 6, 2025.

13 As an OSMA National Delegate, I attended multiple sessions during the AAMA Conference.  
14 Delegate attended the Board of Trustees Endowment Meetings, Mix and Mingle Reception,  
15 Welcome and Awards Celebration, House of Delegates (HOD) Session One, HOD Session Two,  
16 State Leaders Session, and the AAMA Committees, Strategy Teams, and Task Forces Meeting.

18 As delegate, I was charged with attending and reporting on the Reference Committees: Reports,  
19 Bylaws, and Resolutions. The following are highlights of those two sessions:  
20

21 Reference Committee on Reports, Bylaws, and Resolutions: The Reference Committee on  
22 Reports recommended that the reports received from the AAMA Officers, Trustees, Committees,  
23 Boards, Strategy Teams, and Task Forces be approved as presented and filed for future  
24 reference. The motion passed.  
25

26 The Reference Committee on Bylaws recommended that proposed Bylaw Amendment 25-01  
27 Article VIII: Qualification of Officers and Trustees Section 4, not be adopted and returned to  
28 Bylaws committee for revision. Amendment 25-01 was passed.  
29

30 The Reference Committee on Bylaws recommended that proposed Bylaw Amendment 25-02  
31 Article IX: Nominations and Elections Section D, be adopted. Amendment 25-02 passed.  
32

33 The Reference Committee on Bylaws recommended that proposed Bylaw Amendment 25-03  
34 Article IX: Nominations and Elections Section 2: Elections, not be adopted. Amendment 25-03  
35 was not adopted.  
36

37 Texas State Society Proposed Bylaws Amendment 25-04 Article VIII: Qualifications of Officer  
38 and Trustees Section 4 be adopted. The Reference Committee on Bylaws recommended that  
39 proposed Bylaw Amendment 25-04 be adopted. Amendment 25-04 passed.  
40

41 Texas State Society Proposed Bylaws Amendment 25-05 Article X: Officers and Trustees: Term  
42 of Office, Vacancy in Office, Failure to Perform Duties Section 1: Term of Office. The

43 Reference Committee on Bylaws recommended that proposed Bylaw Amendment 25-05 not be  
44 adopted. Amendment 25-05 was WITHDRAWN.
